NOOO SLIP is non-toxic, biodegradable, non-flammable, and non-corrosive. It contains no butyl or petroleum solvents, will not build up or scale equipment, and has a fresh scent.

### DIRECTIONS FOR USE

#### Directions for Use:

Due to various application methods and soil conditions, the following dilutions are given as a guideline. Experiment to find the most effective and economical dilution for each application.

**LIGHT SOIL:** For daily damp mopping, auto scrubbing and use on finished floors, use 1 ounce per gallon of water.

**MEDIUM SOIL:** For general cleaning, damp mopping, and use on low maintenance floors, use 2 ounces per gallon of water.

**HEAVY SOIL:** For scrub and recoat procedures and heavy scrubbing of non-finished floors, use 8-12 ounces per gallon of water.\*

\*Dilutions of more than 2-4 ounces per gallon of water may require the use of a defoamer in the recovery tanks of automatic and wet-vacs.

### GENERAL PRODUCT INFORMATION

**Description:** Low Foaming Neutral Detergent Concentrate
